For the immediate use at the border of Poland and Ukraine due to the ongoing war in Ukraine.





On Monday, 07th March, my colleague Alwin Machold, who is in possession of a C1 LKW drivers license, and I collected the conveyance license plate at the traffic office in Schafisheim near Aarau. We attached it to the discarded former ambulance of Basel which we bought at Act Specialcar in Gretzenbach/AG.

We stickered peace-stickers to the hood and doors of the support vehicle, a VOLVO XC90. The next day, on the 08 March, both cars were loaded with approximately 500 Kg of auxiliary goods, medical supplies provided by the Iseli Hospital, consumables like diapers, toothpaste, snack bars, covers and much more. These were collected by my office neighbor Torge-Nils Eistrup, from Physioswyss Regio-Association of both Basel, by means of an appeal.

My VR &Co-Ceo Gianluca Biggi joined us in Zürich. We alternated driving the Volvo during the fifteen hours long drive.

Drive to Poland

We planned to drive from Basel over Austria and Czech Republic to Poland. In the evening, we arrived at the Strasser Hof Hotel in Strass near Vienna where we refuelled and spent the night after an exhausting drive which included some breaks at rest stops (we were not able duplicate Alwin, who was driving the ambulance). The hotel waived ours costs as they emphatically supported our campaign.














The next morning at 6 am, we continued our journey and soon arrived in the Czech Republic. We were amazed that the highways were so newly paved and that they were almost as nice as in Switzerland. We passed beautiful bridges and even an airplane museum which was probably an airport that had to make way for the highway.







We met a Ukrainian man and a Polish doctor in a white VW transporter and had a talk with them at a rest stop. The man from Kiev lost his home due to the bombing and has three children, which is why he is excused from military duty and can leave and reenter the country. They overtook us one more time and gave us a signal to take the exit. They asked us in a friendly manner if we could fill their 80 liter tank which we did. This probably lasted them all the way to Kiev and back.

Destination Lubanczow

When we arrived at our destination, the border village Lubanczow, we were greeted by Dr. Bayer from the ISAR, who was responsible for the community/ town as well as the hospital management where we parked the ambulance and unloaded everything. Alwin showed them how to handle the ambulance and after a meeting, we had a lovely dinner.

As the hotels in town were fully occupied by Ukrainian refugees due to Poland's extraordinary helpfulness, which we were profoundly aware of. At around 8pm, equipped with approximately three kilos of organic honey (a hobby of the chief rescue officer of the hospital), we hit the road and checked in at the Courtyard Marriott in Katowice in Poland at 10pm. The mentioning of our pro-bono mission was disregarded.















Back via Germany

At 9am, this time a little bit later, our journey continued after we caught up on sleep and had breakfast.

Our drive led us through another route through Poland and Germany, past the Thyssen-Krupp Elevator Test centrum in Rottweil, which almost reached the sky and apparently won quite a few architectural awards, as well as Mercedes Sindelfingen.

On the highway, we also had a special encounter with an Oldtimer which grille figure I first thought was a Bugatti, but my investigation revealed that it was an ALVIS. By the way, animals were commonly used as grille figures but it would exceed this report to name them all.

We arrived in Zurich at around 10pm and Gianluca was the first to be able to rest from our long journey. We reached Basel, our final stop, at 11pm.

As it was my wish that the ambulance vehicle officially belonged to ISAR, it had to be repatriated to Duisburg, Germany (headquarter of ISAR), checked and inspected by TÜV (technical inspection agency) in order to be approved as an ambulance in Germany.



Final accounting

Basic cost for the ambulance CHF 25'000
Reclaimable taxes MWSt. - CHF 893
German costums and 19% taxes CHF 5'563

Total costs CHF 29'670

All further expenses (swiss license plate and insurance, fuel, hotel in Poland, highway fees in Austria and the Czech Republic, meals) in the scope of 1'500.- were taken over by our dear office colleague and friend Andreas Studer.

The driver of the ambulance, Alwin Machold, participated in our mission free of charge.

Carlos Zanotelli and Gianluca Biggi were exempted by their employer for the social engagement.

In the aftermath, we were surprised by the reimbursement obligation of the European Custom-and Import fees (Proper import-registration in the EU-area and authorization as an ambulance with German license plates). These would have only been omitted if the vehicle would have been exported to a non-EU country (e.g. Ukraine directly). This was not possible anymore after ISAR Germany agreed to take over the vehicle, as we did not receive any answer from swisshelpukraine@gmail.com and the embassy in Bern, understandably, was not reachable by phone.

Our client, ISAR Germany – International Search and Rescue, has asked us for help on short notice. ISAR Germany has been gifted an ambulance vehicle. It will be used at the Polish-Ukrainian border in order to help people.

The present from Switzerland needed the complete package within two days for the authorization in Germany.

We worked hand in hand to manage this mission. On Thursday, the vehicle underwent a major inspection. The detected deficiencies were repaired directly.

For the approval of the TÜV, a few more things had to be changed in order for a registration in Germany to be possible. On Friday, we registered the vehicle at SVA Kleve while further minor technical changes were simultaneously performed.

We would also like to contribute so that ISAR Germany can continue providing such excellent and important help.

For that reason, we have decided to take over the costs for the work done as well as the TÜV and registration fees.

Thank you very much for your work and much success with the new vehicle.



The Swiss emergency number 144, correctly, had to be removed, otherwise no one will show up in the EU.


Nevertheless, the rod of Asclepius was a challenge... In the end, it was allowed to stay!
